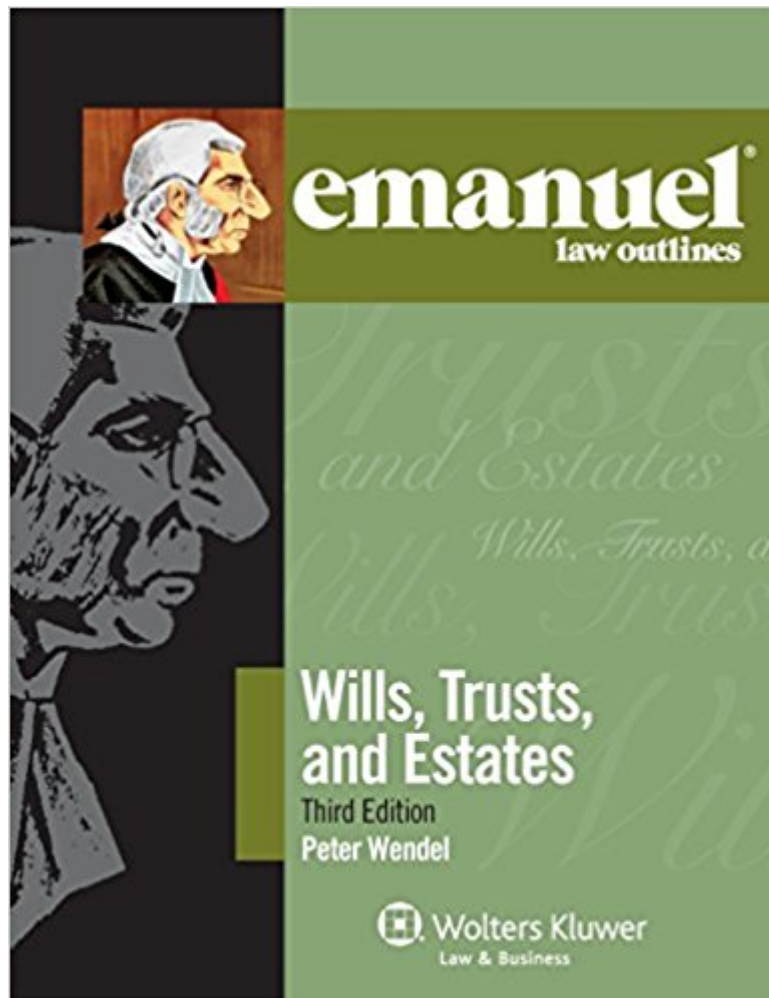

Great book for review! Wouldn't use it as a primary source of learning the material, but it provides all of the old and new rules.

If you're using the Dukeminier Wills, Trusts, & Estates 9th edition casebook, be aware that this Emanuel Outline is keyed to other casebooks but NOT to the Dukeminier. The previous Emanuel Wills Trusts & Estates Outline (2010 edition - purple cover) is keyed exclusively to the Dukeminier

8th edition, but still covers over 90% of the cases in the Dukeminier 9th edition that were on my syllabus (which was pretty comprehensive), and was still extremely helpful. This outline, by contrast, included fewer than 10% of the cases in the Dukeminier 9th edition that were on my syllabus. (No, I didn't check the cases that weren't assigned. I'm in law school.) The only topic in which this edition (green cover) included more cases than the previous edition (purple cover) from Dukeminier 9th edition was the topic of Admission of Extrinsic Evidence. If you're using the Dukeminier 9th edition, I'd suggest getting the 2010 edition of Emanuel and when you get to the Admission of Extrinsic Evidence, just borrow your law library's copy of this 2012 edition for those pages.
