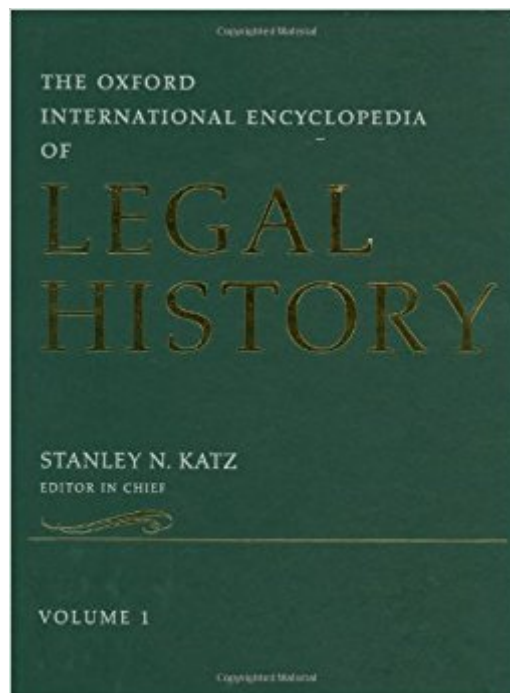

It is the first encyclopedia of law to provide historical and contemporary comparisons of world legal systems.
